TENTATIVE AGREEMENT REACHED WITH AMAPCEO

FROM: Government of Ontario Treasury Board Secretariat Ontario has reached a tentative four-year collective agreement with the Association of Management, Administrative and Professional Crown Employees of Ontario (AMAPCEO).

The negotiated agreement was reached by both sides coming to the table and working co-operatively. The tentative agreement fits within the fiscal plan as outlined in the 2014 Budget, which includes no new funding for compensation increases. This agreement, if ratified, will support the government's ongoing efforts to eliminate the deficit while protecting the valued public services Ontario families rely on.

The Ontario government and AMAPCEO must ratify the tentative agreement before details can be released.

- AMAPCEO represents more than 10,000 Ontario Public Service employees in a broad range of professional and administrative positions.
- The previous collective agreement with AMAPCEO expired on March 31, 2014.
- The Treasury Board Secretariat is responsible for collective bargaining with all Ontario Public Service bargaining agents.

PICNIC AND GRILLING SAFETY TIPS TO KEEP YOUR OUTDOOR EVENT FUN AND SAFE

Whether it's a picnic with friends, or a family barbeque at the park, don't invite food poisoning to the party Each year, thousands of Ontarians suffer from food poisoning due to improper food handling. The risk increases in the summer months due to the warm and humid weather, which allows bacteria to multiply faster, and because more people are eating outside without the conveniences of refrigeration and running water.

The next time you're out for a picnic, firing up the grill, or preparing any meal, practice these safe food handling tips:

- **Clean** -- make sure hands, utensils, preparation surfaces and all produce are washed before eating and/or cooking
- **Separate** -- keep raw meat, poultry and fish away from ready-to-eat foods during storage and preparation
- **Cook** -- cook food thoroughly -- especially meat -- paying close attention to cooking times and temperatures, as they can vary
- **Chill** -- refrigerate or freeze perishables, prepared food and leftovers within two hours. When transporting food, surround it with icepacks in a cooler.

Additional precautions you can take while prepping food at home:

- **Never defrost food on the kitchen counter.** The outer layers of food will defrost before the inside thaws. Bacteria can grow under these conditions. Thaw meat safely either in the refrigerator or under cold running water before cooking.
- **Marinate meat in the refrigerator**, not out on the counter. If using marinade to baste cooked meat or as dipping sauce, set aside marinade before combining it with raw meat.
- **Reduce bacterial growth** by keeping chilled foods cool (4 degrees Celsius and below).



Notice of Commencement of Environmental Assessment and Open Houses — New East-West Tie Transmission Project NextBridge Infrastructure

NextBridge Infrastructure (NextBridge) – a partnership between NextEra Energy Canada, Enbridge Inc., and Borealis Infrastructure – has initiated an Environmental Assessment (EA) under the *Environmental Assessment Act* to construct a new, approximately 430 km double-circuit 230 kV transmission line connecting the Wawa Transformer Station (TS) to the Lakehead TS in the Municipality of Shuniah near Thunder Bay, with a connection at the Marathon TS. The new East-West Tie generally parallels an existing double-circuit 230 kV transmission line corridor (the existing East-West Tie) but avoids sensitive features crossed by the existing line. Routes under assessment are depicted on the map below.



The Ontario Power Authority (OPA), the provincial agency responsible for long-term electricity planning, identified the expansion of the transmission system between Wawa and Thunder Bay in order to maintain a reliable, long-term supply of electricity to northwestern Ontario. Industrial activities in northwestern Ontario, particularly in the mining sector, are expected to drive electricity demand growth in the coming decade. Coupled with changes to the electricity supply in the area, the OPA has identified supply needs for the northwest, which can be met with additional transmission or generation. The OPA analyzed these alternatives and recommended expansion of the East-West Tie based on technical, economic and other considerations. The East-West Tie was included as a priority project in the Government of Ontario's 2010 Long Term Energy Plan. The target in-service date is the first half of 2018.

The Proposed Terms of Reference (ToR) document was submitted to the Ministry of the Environment and Climate Change on February 28, 2014. The Proposed ToR document was amended in response to stakeholder feedback and resubmitted on May 22, 2014. Approval of the Proposed ToR by the Minister of the Environment is expected. In anticipation of ToR approval, NextBridge has initiated data collection for the EA and will be holding Open Houses in support of the EA as indicated in this Notice. The EA will be carried out according to the approved ToR and the requirements of the *Environmental Assessment Act*.

A draft of the EA will be made available for review and comment. The EA will then be updated as required and submitted to the Ministry of the Environment and Climate Change for review, which will include an additional public review component. Notification will be given both for the Draft EA Review and the review associated with submission of the EA to the Ministry of the Environment and Climate Change. Notice will be provided indicating when and where the draft and finalized EA can be reviewed.

In accordance with the Aboriginal Duty to Consult delegated to NextBridge by the Crown, First Nations and Métis communities will be consulted on the route and the EA.

Public Open Houses Round Two

Active participation in the EA process is encouraged by contacting project staff with questions, comments and by attending Open Houses for the Project. Engagement and discussion opportunities, such as Open Houses, will be held throughout the EA and will be advertised through mailings, newspaper notices, and through postings at www.nextbridge.ca.

The first round of Open Houses was held during the development of the ToR. Two more rounds of Open Houses are planned for the EA. The second round is scheduled for the week of August 18, 2014. This round will provide an opportunity to learn about the Project, the EA and Leave to Construct processes, results of background studies and studies to take place during the EA, routing considerations and decisions to date, land and property matters and next steps in the EA process.



NextBridge Infrastructure (NextBridge) - un partenariat entre NextEra Energy Canada, Enbridge Inc., et Borealis Infrastructure - a lancé une évaluation environnementale en vertu de la Loi sur les évaluations environnementales afin de construire une ligne de transport à double circuit de 230 kV d'une longueur d'environ 430 km, pour relier le poste de transformation (PT) de Wawa au PT de Lakehead, situé dans la municipalité de Shuniah près de Thunder Bay, avec une connexion au PT de Marathon. GOLDIE OLDIES DONATED - GREENSTONE HISTORICAL SOCIETY ACQUIRES PHOTOS

Information provided by Edgar J. Lavoie, Greenstone Historical Society **GREENSTONE, ON** - Remember when the *Times Star* sold for 5 cents? Few people in Greenstone can. But in 1946, when brothers Gordon and Douglas Goldie and George Hendry acquired the Times-Star newspaper from Walter Brehner, that was the price.

Recently, Doug Goldie's daughter Bonnie (visiting with her husband Derek McIlveen for what they speculated was the first time in 45 yrs) dropped off some memorabilia to the Greenstone Historical Society (GHS) which her mother had been given when Doug passed.

Edgar Lavoie, President of GHS, accepted the memorabilia which included an album chockfull of historic photos, most of which Lavoie had never seen before, and a bound volume with several copies of old Times Stars.

Back in '46 Gordon Goldie acted as editor, Doug Goldie as advertising manager, and George M. Hendry as business manager. The paper was printed on an antiguated linotype machine, subject to frequent breakdowns and nicknamed Lizzie.

The Times-Star served the whole of what is now referred to as the Municipality of Greenstone. The stories must have been quite impressive for a community newspaper as within a matter of months, it won second-prize in a contest sponsored by Canadian Weekly Newspaper Association. The original certificate of achievement is among those documents preserved in the Goldie album.

"The history of Geraldton is still being written because it is still being discovered, thanks to people like Mrs. Goldie and Derek and Bonnie McIlveen." commented Edgar Lavoie.

Lavoie also explained that the Greenstone Historical Society is still looking for a permanent home for its artifacts and documents.

August 4th, Kenogamisis Fish & Game Conservation held an open house at its lodge in Geraldton welcoming people to drop-in, talk about the 'good old days' and even peruse an old membership ledger. Enjoy Edgar Lavoie's article and photos related to the event at www.OntarioNewsNorth.com/?p=57669.
