Index Item 02) Municipal By-Law Frequently Asked Questions (FAQ's)

Q ? Can you tell me where I can find information about a certain by-law?

A ? Most Municipal By-Laws which are enforceable are available online @ www.manitouwadge.ca or can be requested from the Municipal Law Enforcement Office (MLEO) located at the Municipal Office, 1 Mississauga Drive during business hours. Q? How do I report a by-law related matter which is between us and our neighbour?

A? At times, a neighbour may not be aware of a by-law related matter which is causing a problem for their neighbours. Usually, it is best and if possible, to initially talk with your neighbour respectfully, let them know what the problem is. If there is no resolution, you may contact the (MLEO) to report the problem and find out if the matter is by-law related, to avoid receiving any incorrect by-law information from others OR which may be printed or shared in the community by various means.

Index Item 03) Responsible Pet Ownership

THINKING OF OWNING A PET?

Before you decide to acquire a pet, you should make certain that you will be able to take care of your pet properly. This means, financially, physically AND emotionally, i.e., appropriate shelter from heat and cold, positive attention, quality food, daily fresh water, proper exercise and regular medical care.

This is in addition to having your pet spayed and/or neutered and if applicable licenced. This year the heat temperatures are so hot. Every precaution should be taken to prevent dogs from heat stroke or heat exhaustion while jogging or when left in a vehicle for even a short period of time on a hot day. Sitting in the back of a truck can be equally devastating to a dog as when left outside without shade or water.

Pets shouldn't have to suffer just because YOU were the one that wasn't prepared to take care of them properly.

TAKE GOOD CARE OF YOUR PETS, IT WAS YOUR CHOICE TO OWN THEM, NOT THEIRS!



Index Item 04) Dog By-Law

The common occurrences relating to our dog by-law occurs when a dog leaves its property. Dog owners are responsible for the control of their pet dog when on their property and when a dog is away from their property. **Visit Dog Owners Liability Act @ www.e-laws.gov.on.ca.** Dog occurrences such as a dog leaving excrement on private/public lands, causing a nuisance or injury to a person or animal, being injured by a vehicle, animal or other means can be eliminated if your pet is not permitted to be at large. **In keeping with our goals to provide a safe and clean community to live in, PLEASE ensure your pet dog does not run at large.** Spaying/neutering your pet dog may prevent unwanted litters and eliminate their need to roam and go after other dogs tied on their own property.

DOG BY-LAW No. 92-45

Manitouwadge Dog By-law, No. 92-45, being a By-law to prohibit and regulate animals and licence dogs.

Section 2-Dog Licencing

2(1) -Dogs must be licenced annually, no later than January 31st of each year or within 15 days of becoming the owner of a dog.

2(6) -No person making application for a dog licence shall make a false statement on the application form.

Section 5-Dog Tags

5(1) -Every dog owner shall keep the current dog tag securely fixed on the dog for which it was issued at all times, until the dog tag is renewed or replaced.

Section 6-Dogs At Large

6(1) -The owner of every dog shall prevent such dog from running at large.

6(2)- For the purpose of this by-law, a dog shall be deemed to be running at large when found in any place other than the premises of the owner of the dog and not under the control of any person.

Section 7-Leashing of Dogs

Except where the owner of the land upon which a dog is found has given consent, every owner of a dog shall be required to keep the dog leashed on a leash of not more than three (3) metres in length and under control of some person when the dog is on any land within the Township of Manitouwadge.

Section 8-Dog Waste

8(1) Every owner of a dog or person having control of a dog shall forthwith remove excrement left by the dog anywhere within the Township of Manitouwadge.

Section 10-Relating to Dogs and Other Animals General

10 (1) (b) - No owner shall keep more than six (6) animals, including dogs, in or about his or her dwelling unit.

10 (2) - No animals that could be described as indigenous, wild or dangerous to human life, may be kept by any person, in or about any dwelling unit in the Township of Manitouwadge.

Section 11 Municipal Pound

The Municipal Law Enforcement Officer is responsible to receive and impound all dogs running at large and notify owner of such dog being impounded, **if able**. Cost for impounding any dog for any period of time is \$50.00 per day. Additional penalties may also occur if dog is not licenced for the Township of Manitouwadge for the current year.

Section 12- Penalties

Every person who contravenes any provision of this By-law is guilty of an offence and the matter will be dealt with as provided for in the Provincial Offences Act from time to time as amended.

*****Note-Consider purchasing a Dog Licence (Tag) for \$20.00 Altered and \$ 35.00 Unaltered.**

Such information on the dog licence can allow the Township to return a dog to their owner, **providing the dog has not been problematic.** Even better...purchase your dog tag early during our “**Early Bird Advanced Dog Tag Sale**” usually held between the first week of December and the first week of January as great prizes can be won !!!

Index Item 05) Cat By-Law

The Municipal Pound does live trap feral/domesticated cats due to stray cats delivering litters of kittens in residents sheds, back yards etc. This can be avoided if cat owners spay or neuter their cat and keep cat secured on property, if the cat wants to enjoy the outdoors. Common complaints from residents regarding cats have occurred when their patio door screens have been ripped by stray cats, flower beds have become litter boxes with cat feces and in some areas, cats have sprayed a stench of urine on homes.

Responsible pet owners who tie their own cat or dog on their property have also experienced a stray cat coming onto their property and become a nuisance to the tied cat/dog or pets near a window inside a home. We currently have a few cats at the Municipal Pound who require adoption very soon (see back cover) as no owner has claimed them and we are expecting more to arrive as there have been at least ten strays we are aware of at this time. If a stray cat shows up at your door, PLEASE call the Township to arrange for pick-up if possible at that time.

CAT BY-LAW No. 2003-10

Cat By-Law No. 2003-10, Being a By-law to regulate and control cats in the Township of Manitouwadge.

Section 2 General Provisions

S.2.1 No owner shall permit or allow his/her cat to be at large.

S.2.6 No owner shall permit his/her cat to defecate on private/public property.

S.2.7 No person shall tease, torment, annoy or abuse any cat.

S.2.8 No person shall allow their cat to emit animal sounds or other noise for an extended or frequent periods of times.

S.2.9 No person shall interfere with or impede a Municipal Law Enforcement Officer in the performance of any duty authorized by this by-law.

S.2.12 No person shall keep or harbour or permit to be kept or harboured, more than six (6) animals, including cats on property in the Township of Manitouwadge.

Section 3 Registration And Identification Of Cats

S.3.1 When requested to do so, an owner shall provide the Municipal Law Enforcement Officer a statement in writing as to the number of cats owned by him/her that are kept on the property of the cat owner.

S.3.2 The owner of a cat shall annually register each cat, pay the prescribed fee before January 31st of every year and obtain an identification tag for the cat.

S.3.3 The owner must ensure the identification tag is securely fastened to the cat.

Section 5 Cost Recovery

The cost of taking possession of an impounded cat is \$ 50.00 per day.

Section 7 Enforcement

Every person who contravenes any provision of this By-law is guilty of an offence and the matter will be dealt with as provided for in the Provincial Offences Act as amended from time to time.

*****Consider purchasing a Cat Licence (Tag) for \$20.00 Altered and \$ 35.00 Unaltered.**

Such information on the cat licence can allow the Township to return a cat to their owner, **providing the cat has not been problematic.** Even better...purchase your cat tag early during our “**Early Bird Advanced Cat Tag Sale**” usually held between the first week of December and the first week of January as great prizes can be won !!!

Index item 06) Garbage By-Law

Garbage By-Law 91-25

Garbage By-Law 91-25, Being a By-law to provide for the collection, removal, disposal of garbage and other refuse within the Township of Manitouwadge.

General Prohibitions

2. No person shall sweep, throw, cast, lay or deposit, or direct, suffer or permit any servant, agent or employee to sweep, throw, cast, lay or deposit any ashes, garbage, dirt, stones rubbish, or refuse of any kind whatsoever in or upon any street or public place within the Township.
3. All collectible waste may be deposited at the Municipal Landfill Site in accordance with the supervision and direction of the Superintendent.
4. No person shall pick over or remove any ashes, garbage, rubbish or other refuse placed for collection or disposal by a householder.
5. No person shall burn or otherwise dispose of any collectible waste, other than in the manner provided for in this by-law.
6. No person shall place for collection any material or object which may be likely to explode.
- S. 7 No person shall deliver for collection any refuse of any kind to any premise not actually occupied by such person.
- S.8 Every householder shall provide and maintain in good repair, metal or other suitable watertight receptacles sufficient in number to hold all collectible waste produced in or emanating from the premises.
- S.8(b) No householder shall place for collection any collectible waste unless it is contained in receptacles which conform with the following criteria:
 - i) must be watertight and made of metal or other suitable material
 - ii) must be equipped with handles;
 - iii) must have properly fitted covers in place;
 - iv) the interior shall be smooth and free of obstructions which may impede the removal of collectible waste.
- S.8(c) No householder shall place for collection a receptacle, the weight of which, together with its contents, exceeds twenty (20) kilograms.
- S.8(e) Dumpsters shall be for the exclusive use of the dumpster owners or lessees and use by any person or business other than the dumpster owner or lessee shall be strictly prohibited.
- S.13 No person shall convey through the streets any garbage, or refuse, except in covered receptacles or in vehicles equipped with a fastened canvas cover/tarp, to prevent waste from falling off the vehicle, **including construction materials.**

Index Item 07) Use Of Bear Proof Dumpsters

Please use the Bear Proof Dumpsters (stenciled with bear image) **regularly between the hours of 6:00 AM and 11:00 PM** for **household kitchen waste only** which has been well wrapped and drained of all liquid matter.

Bear Proof Dumpsters are monitored and will be removed from an area if they are abused by the disposing of rubbish, wood, broken glass, metal scraps or any hazardous or manufactured and trade waste into them.

Index Item 09) DISCHARGE OF FIREARMS BY-LAW No. 94-39

By-Law 94-39, Being a by-law to regulate and prohibit the discharge of firearms within the Township of Manitouwadge.

Section 1. Definitions: In this by-law:

- A) “Firearms” includes any rifle, shotgun, air or pellet gun, longbow and crossbow.
- B) “Township of Manitouwadge” includes the whole of the geographic townships of Mapledoram, Gertrudge, Gemmell, Leslie, and includes the improved townsite of the Township of Manitouwadge.



REMEMBER THE (3) (2) and (2) RULE !

Section 2. Prohibited Areas

No person shall discharge any firearm in the Township of Manitouwadge and in the described areas which is radially distant:

- A) **Three (3) km** from the centre of the **Traffic Circle** located at the intersection of Manitou Road East and West Mississauga Drive and Oshweken Road.
- B) **Two (2) km** from **Manitouwadge Landfill Site** on the Caramat Road.
- C) **Two (2) km** from the Township **Municipal Airport** on Hwy 614.

NOTE: Anyone requiring additional information on boundaries can pick up a copy of the by-law from the Municipal Office Receptionist.

Copies are also available at the Manitouwadge O.P.P. Detachment.

Index Item 10) Land Maintenance By-Law

Its great to see so many property owners in town taking pride in how they keep their yard tidy and clean.

This summer, efforts were made to remind property owners to keep their grass trimmed as per Land Maintenance By-law 97-09. A section of this by-law is being considered for an amendment through the Municipal Act, which will permit the Township to cut grass on private property, should a property owner remain non-compliant when their grass height continues to exceed the height allowed in the by-law. This ensures the grass on private properties in town don't remain unkempt. The fee for cutting the grass can also be recovered by the Township under the Municipal Act.

Many yard complaints can be eliminated if every property owner or tenant becomes mindful of what is stored or accumulated on their front/rear yards and asks themselves:

Is there anything I should remove, sell or store elsewhere because I don't use it or because it's unsightly to others ?
Do I have permission to store my objects or materials on someone else's land (private property) or (public lands)?

The Township has greatly assisted in such removals during *Spring Clean-Up Week* when arrangements are approved with the Township prior to a pick-up. There are also handyman businesses in town that will assist with the removal of unwanted materials.
Community pride can really make a town stay beautiful !

Land Maintenance By Law No. 97-09



Land Maintenance By-Law No.97-09, Being a by-law to provide for maintaining land in a clean and clear condition.

Section .4.1 No person shall deposit or cause to be deposited waste or objects on any lands that may create a health, fire or accident hazard;

Section 4.5 Grass and/or weeds shall be kept trimmed so as to not exceed 20 centimeters (8 inches) in height

Section 5.1 No person shall permit land to be used for the storage of inoperative motor vehicle(s) or parts there of except in compliance with this by-law

Section 6.1 No person shall permit or cause to be permitted the throwing, placing or depositing of waste on private land or public lands

PLEASE NOTE: No person shall deposit or cause to be deposited any biodegradable waste such as grass, leaves, bark, brush, concrete, wood etc. within the Township of Manitowadge-all debris is to be taken to the Landfill site.

Index Item 11) All Terrain Vehicle By-Law

The Township of Manitouwadge and the Manitouwadge Conservation Group will post (4) signs on the Perry Lake Trail, advising all unauthorized motorized vehicles to not enter into the Perry Lake Trail area for the safety of individuals/pets who frequently enjoy a walk on these trails **AND to prevent damage to the trail which is occurring.** Owners and operators of any unauthorized motorized vehicle including all terrain vehicles (ATV's), are advised to stay away from this area as per the All Terrain Vehicle By-law. It is the owner of the ATV's responsibility to **review the ATV By-law Schedule "A" for prohibited areas and inform any operators of where ATV's are not to operate.** Visit www.manitouwadge.ca or pick up a copy from the Municipal Office. See also www.e-laws.gov.on.ca for Off-Road Vehicles Act Provincial Statute.

Prohibited Areas (Excerpts Only) are: Any sidewalk, pathway, footpath in the Township, used by or set apart for the use of pedestrians and forming part of any highway or bridge or boulevard, any public park, the Kiwissa Ski Hill, Lions Beach Playground area, Ballpark or Recreation Field, Golf Course, Airport, Landfill Site, Community Centre and grounds, municipal gravel pits, Huron Walk, Shebandowan Ave, Cross Country Ski Trails, any street in the downtown core and easement at rear of Otter Ave and Beaver Drive from Station Road to Deer Ave.

All Terrain Vehicle By-Law 2005-011

Section 1. Definitions: a) "all terrain vehicles" means an off road vehicle,

- i) has four wheels, the tires of which are in contact with the ground,
- ii) has steering handlebars,
- iii) has a seat that is designed to be straddled by the driver, and
- iv) is designed to carry a driver only and no passenger;

b) "highway" includes a common and public highway, street, avenue, parkway, driveway, square, place, bridge, viaduct or trestle, designed and intended for, or used by, the general public for the passage of vehicles.

c) "municipality" means the Township of Manitouwadge

d) "off-road vehicle" has the same meaning as in the Off-Road Vehicles Act O. Reg 316/03, s.1. as amended from time to time.

Section 2. Times of Operation: No person shall operate an off-road vehicle on or across a highway or part thereof between the hours of 11:00pm-6:00am

Section 3. Speed Limit: In accordance with Section 22 of the Highway Traffic Act O. Reg 316/03, as amended from time to time. The maximum speed limit within the Township of Manitouwadge **shall not exceed twenty (20) kilometers per hour.**

Section 4. Prohibited Areas: No person shall operate or permit the operation of an all terrain vehicle so as to contravene any of the prohibited areas

Section 5. Operation of All Terrain Vehicles: The rules regulations & provisions governing the operation of all terrain vehicles as set out under the Off-Road Vehicles Act R.S.O 1990, Chapter 0.4 and under the Highway Traffic Act O. Reg. 316/03 as amended from time to time shall apply to the operation of all terrain vehicles within the Township of Manitouwadge

Section 6. Penalty

Every person who contravenes any provision of this By-law is guilty of an offence and is liable upon conviction, to a fine as provided for in the Provincial Offences Act as amended from time to time.

Please obey the rules of the road/by-laws and have a safe ride!



Index Item 12) Watering By-Law

WATERING BY-LAW 2004-019



Watering By-law 2004-019, Being a by-law to regulate time, manner, extent and nature of outside water usage in the Township of Manitouwadge

Please be advised that from March 1st to November 31st of every year, no person shall use cause or permit the use of water externally through a hose, pipe or any other watering device or mechanism, for lawns, gardens, or other outside plants, grass, plots, boulevards or grounds of any description or washing of any vehicle, trailer, boat, driveway, side-walk except in accordance with the following:

- Premises with even street numbers on even numbered calendar days **0,2,4,6,8**
- Premises with odd street numbers on odd numbered calendar days **1,3,5,7,9**

“Calendar day” shall be construed to mean on one day commencing at 00.00 hours and ending at 23:59.59, local time

Index Item 13) Parking By-Law

Handicapped parking spaces are **ONLY** for such vehicles which bear a handicap permit.

A person requiring such a permit can visit our local Service Ontario Office to inquire about getting a Handicap Parking Permit.

It is appreciated that many drivers of vehicles have made changes and are not parking on Shebandowan Street near the Loblaws Mall and in the Fire Lane located between the Bargain Shop/Loblaw’s Mall, where signs are posted to not park.

Some of the common parking infractions occurring at this time which will be enforced are:

- 1) Vehicles are parking facing the wrong direction (Section 2).
- 1) Vehicles are parking too far from the edge of the roadway (Section 3).

PARKING BY-LAW 95-15

By-Law No. 95-15, Being a by-law to regulate parking.

Section 7. Handicapped Parking Zones - No person shall park, stop or stand a vehicle in a handicapped parking space unless such vehicle bears a handicap permit and is operated by or actually transporting a handicapped person.

Section 8. October 1st to April 30th -No person shall park, stand or stop a vehicle on any public highway in the township between the hours of 2:00am and 6:00 am local time, from first day of October in each year to and including the 30th day of April in the next following year.

Section 10. Parking Prohibited Without Signs-No person shall park a vehicle or permit a vehicle to remain parked on a highway or lane: a) within 12 metres of the offloading of a dumpster, b) within 9 metres of an intersection, c) within 3 metres of a fire hydrant, d) within 1.5 metres of a lane-pedestrian way, crosswalk, e) for the purpose of displaying a vehicle for sale, f) for the purpose of washing, greasing or repairing a vehicle-except when necessitated in an emergency.

Index Item 14) Heavy Truck By-Law

Heavy Truck By-Law 88-69

Heavy Truck By-Law, Being a by-law to regulate traffic and to prohibit parking of heavy traffic.

Section 2.a) No vehicle having a registered gross weight greater than 7500 kg shall be operated on any of the highways within the boundaries of the Corporation, except on those highways, or portion of highways set out in Schedule “B” to this by-law:

- 1. Manitou Road
- 2. Station Road
- 3. Those portions of highways which are within the industrial area:
 - a) Station Road
 - b) Pic Road
 - c) Black Road
 - d) Superior Avenue
 - e) Sault Road
- 4. Those areas outside of the Townsite boundaries. (See Schedule “B” in by-law.)

2.b) Between the hours of 8:00 a.m. and 8:00 p.m., No vehicle having a registered gross weight greater than 7500 kg shall be parked, stopped or left standing on any of the highways within the boundaries of the Corporation, or in any parking lot within the boundaries of the Corporation.

2.c) Between the hours of 8:00 p.m. and 8:00 a.m., No vehicle having a registered gross weight greater than 7500 kg shall be parked, stopped or left standing on any of the highways within the boundaries of the Corporation, or in any parking lot within the boundaries of the Corporation, except on those highways or portions of highways or parking lots where signs have been erected by Corporation authorizing such parking, stopping or standing.

Section 3. This By-law shall not apply to vehicles while actually engaged in construction/maintenance of highways, emergency fire vehicles, school buses, passenger buses, vehicles affecting deliveries or pick-ups from any premises abutting such highways, fuel delivery trucks, moving vans.

Section 4. The owner of the vehicle and/or person violating the provisions of this by-law may be held liable if convicted under the Provincial Offences Act as amended from time to time.

Index Item 15) Noise By-Law (Excerpt Only)

Noise By-law 98-09

By-law 98-09, Being a by-law to control noise.

Section 1. No person shall ring any bell, blow or sound any horn or cause to be rung, blown or sounded, shout create, cause or permit any unusual noise or noises likely to disturb the inhabitants.

Section 2. d) Any sound made by a pet animal which disturbs the peace, quite, comfort or repose of any individual in the neighborhood.

Index Item 16) Fireworks By-law (Excerpts Only)

Fireworks By-Law 2009-08

By-law 2009-08, Being a By-law to prohibit and regulate the sale of fireworks and the setting off of fireworks.

- Section 2.1** No person shall set off any firecracker within Township of Manitouwadge.
- Section 2.2** No person shall set off any fireworks within Township of Manitouwadge.
- Section 2.3** A Public Fireworks Display is exempt providing valid permit is obtained from the Fire Chief of the Township of Manitouwadge.
- Section 2.4** No person shall set off any fireworks in, on or onto any building, highway, sidewalk, municipal property.
- Section 2.5** No person shall set off any Public Fireworks Display unless they have received a permit.
- Section 2.6** No person shall display, offer for sale, or sell fireworks within the Township of Manitouwadge.
- Section 2.7** No person shall sell, cause or permit to be sold, any fireworks to a person who is less than 18 years old.
- Section 2.8** No person shall display, offer to sell or sell any firecrackers.
- Section 2.9** No person shall sell or offer for sale any fireworks in any outdoor location or from any motor vehicle.
